



AMENDMENT IN THE PARTNERSHIP CONTRACT

Together or separately, the party or parties

It has been established that:

The parties have signed a « partnership contract », (hereafter « the Contract »), according to which EVANEOS and the DMC have common obligations.

The Parties have decided to establish the present amendment in order to modify the Contract.



The following has been established:

Article 1. Modification of the preamble

From now on, the preamble of the Contract will be written as follows:

« Preamble

EVANEOS offers a platform to promote travel products offered by a local agent acting as a Destination Management Company ("the DMC") via the Internet, together with a payment platform to facilitate these operations.

EVANEOS is a supplier of computerized tools and of content and information via the Internet, which allows French or foreign DMCs to promote their travel services, to respond to their client enquiries and to sell their tours at a price equivalent to the prevailing "direct" price.

The DMC wishes to increase its sales on the German speaking markets by improving its communication, the quality of the enquiries it receives, and the treatment of those enquiries.

The Parties have therefore convened to jointly define the terms of their partnership. »

Article 2. Modification of article 6.1 « Exclusivity » of the contract

From now on, Article 6 of the Contract will be written as follows:

« 6.1 Exclusivity

The DMC agrees not to receive enquiries from German speaking markets and submarkets from other platforms similar to EVANEOS. In case of doubt as to whether this clause applies, the DMC agrees to contact EVANEOS and to explicitly seek EVANEOS' agreement for any similar referencing.

Article 3. Modification of article 4.1 « Transaction fees » of the contract

« 4.1 Transaction fees

All payments made by the travellers to the local agency must go through the payment platform provided by EVANEOS.

EVANEOS charges the DMC a transaction fee of 1.5% of the total amount passing through the platform for this service. This 1.5% fee should not increase the final price charged by the DMC.»

Article 4. Divers

The other articles of the Contract which are not modified by this amendment remain unchanged and remain effective between the Parties.



This amendment will be enforced starting from the day of its signature.
