DAY 1 Sunday, 22 March 2020

On arrival at O.R. Tambo International Airport the guests will be met and welcomed by a representative from Into Africa. They will be handed their travel documents and then transferred to The Palace of the Lost City Hotel.

Official check in to the rooms at the hotel is only from 14h00, so if the room is not ready for check-in on arrival, the guests can leave their luggage at reception and explore the resort.

The rest of the day and evening is at leisure.

Visible from almost anywhere on the resort, The Palace of the Lost City's unique towers with elephant tusk embellishments are a symbol of the true luxury and splendour that the hotel offers. The hotel is surrounded by lush botanical gardens, trickling streams and hidden walking trails. The Grand Pool is the ideal place to relax and take in some African sunshine.

Shepherd's Tree Game Lodge is a lodge concession located in the Pilanesberg National Park, a 2.5-hour drive from Johannesburg. The National Park is famous for its Big Five and is a malaria free zone. The lodge boasts 13 family suites (136sqm) and 4 spacious executive suites (86sqm). The family suites offer two en-suite master bedrooms with a shared lounge and patio. The Executive suites offer one en-suite master bedroom with a lounge and patio. In addition, guests can enjoy an indoor steam shower and double outdoor shower. The placement and design of each suite ensures privacy and uninterrupted views. Each suite offers the highest quality equipment and plasma screen TV, Satellite Television.

DAY 7 – DAY 9 Saturday, 28 March 2020 – Monday, 30 March 2020

On these mornings, guests will be woken up early and taken on a morning game drive, returning to the lodge for breakfast.
